

Crédit Agricole Cariparma completes the acquisition of a majority stake in Cesena Savings Bank, Rimini Savings Bank and San Miniato Savings Bank

Milan, 21st December 2017 – Following the disclosures made on 29th September 2017, Crédit Agricole Cariparma reports that today it has concluded the acquisition of 95.3% stake in the share capital of Cassa di Risparmio di Cesena S.p.A., Cassa di Risparmio di Rimini S.p.A. and Cassa di Risparmio di San Miniato S.p.A. (the "Banks") from the Schema Volontario of the Fondo Interbancario di Tutela dei Depositi (the "Voluntary Scheme").

The entry of the three Banks in the Crédit Agricole Italia Banking Group represents the final transition of a broader transaction in which:

- 1. the Voluntary Scheme brought additional capital resources to the three Banks, designed to achieve an aggregated CET1 ratio pro-forma higher than 10.7%;
- 2. the Banks have completed (i) the securitization of €2,740m of gross NPEs (bad loans and unlikely-to-pay) and (ii) the straight sale of €286m of gross NPEs (bad loans and unlikely-to-pay).

In January 2018 the shareholders' meetings of the three Banks will be held to appoint new Board of Directors and supervisory bodies.

"We are satisfied that we have concluded a complex transaction on schedule – commented Giampiero Maioli, Senior Country Officer of CA in Italy and CEO of the Crédit Agricole Italia Banking Group – made possible thanks to the effective cooperation of all the Italian institutions involved in the transaction.

Negotiations with the Voluntary Scheme of the FITD and with the other parties involved have been exemplary in terms of willingness and commitment.

Starting today, our efforts will be aimed at the three Savings Banks, our new colleagues and their Clients, in order to initiate a new journey in the spirit of development, strengthening and sustainable growth".
